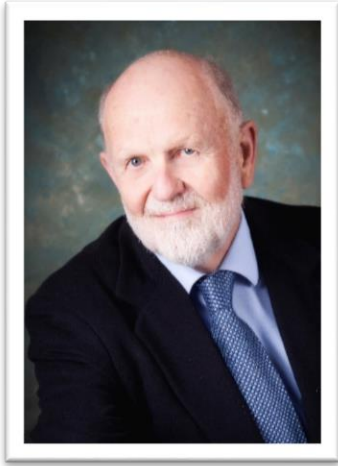


Heidi Phaneuf, Public Outreach Committee Chair

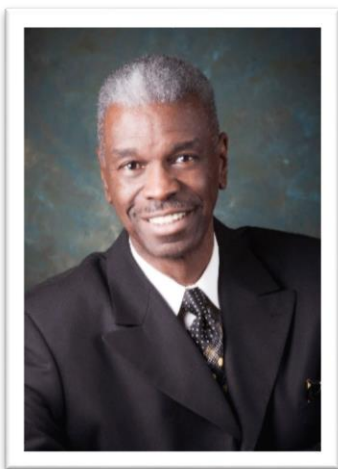


Marsha Wesley, Finance Committee Chair
